**General Conditions:**

The Syracuse Ski Hawk, a non-profit membership corporation, hereinafter called the "Club," with the approval of its Board of Directors, shall make such arrangements and enter into such agreements to deem necessary for each trip. Each member, hereinafter call the "Participant," by signing the agreement, agrees to be bound by and comply with all terms and conditions contained herein.

It is understood and agreed that each Participant is in a joint venture, and as such is responsible for a pro rated cost for the trip. The Club reserves the right to cancel any trip at any time. The Board of Directors shall approve any changes to the Participant as a result of such cancellation.

The Club reserves the right, subject to the approval of the Board of Directors, to change the trip price or make additional assessments at any time, but not later than thirty (30) days after the trip is completed to recover unforeseen, excessive, or non-budgeted expenditures, incurred during the execution of the trip. A surplus of funds resulting the trip shall revert to the club's general fund to offset the costs of publicizing and arranging the trip program.

All deposits are strictly non-refundable. Deposits will be accepted up to trip departure, first served basis until trip is filled, after which time trip chairperson will maintain a waiting list. Full payment for the trip shall be due and payable four (4) weeks prior to trip departure, unless a special installment payment schedule is published for the specific trip. Participant shall become fully liable for each payment on its due date.

Unless cancellation notice is received in WRITING at least four (4) weeks prior to trip departure, Participant shall become liable for full payment.

If the trip package is transferable between individuals, and if Participant finds his own replacement, he may transfer his place to that replacement, and receive from that replacement reimbursement for all payments he has made, except that any person on the trip chairman's waiting list shall be given priority to become that Participant's replacement.

If places on the trip are NOT transferable, no refund whatsoever shall be payable to the Participant regardless of when his cancellation notice is received, except to the extent provided for by the parties furnishing services to the Club in conjunction with the trip. Participant, by signing this agreement, holds the Club harmless, and waives all rights of regress for any injuries sustained, and for any additional expenses incurred, and for any other kind of liability whatsoever that may arise during the course of the trip, or its cancellation.

Each Participant shall be completely and individually responsible for his own actions and shall bear the burden of all liabilities incurred hereafter.

After trip arrangements have been finalized, Participants may be required to sign a supplement to the agreement, which will reflect conditions specifically related to a particular trip.
